3. **L12-197 - Morehouse Parish, Bonne Idee Gravity Drainage District** - 1.29 mills tax, 10 years, 2013-2022, construction, development, maintenance, and operation (limited to the upper banks of Bayou Bonne Idee), including payment of election costs.
4. **L12-212 - Rapides Parish Police Jury** - 7.08 mills tax, 10 years 2014-2023, improving, constructing, maintaining and operating the parish library and its branches.

15. **L12-200 - Livingston Parish, Sewerage District No. 2** - Not exceeding \$580,000 Revenue Refunding Bonds, Series 2012, not exceeding 4%, mature no later than March 1, 2024, **(1)** refunding Revenue Bonds, Series 1984 and **(2)** funding a reserve fund.
16. **L12-211 - Orleans Parish, City of New Orleans, Downtown Development District** - Not exceeding \$6,000,000 Limited Tax Refunding Bonds, Series 2012, not exceeding 5.50%, mature no later than December 1, 2026, refunding Limited Tax Bonds, Series 2001.
17. **L12-214 - Pointe Coupee Parish School Board, School District No. 10** - Not exceeding \$2,000,000 General Obligation Refunding Bonds, in one of more series, not exceeding 3.5%, mature no later than 8 years, refunding all or a portion of General Obligation School Refunding Bonds, Series 2005.
18. **L12-198 - St. Tammany Parish, City of Slidell** - Not exceeding \$4,250,000 Utilities Revenue Refunding Bonds, Series 2012, in one or more series, not exceeding 5%, no later than March 1, 2024, **(1)** refunding Utilities Revenue Bonds, Series 1996A and 2004 and **(2)** funding a reserve fund.
19. **L12-203 - Terrebonne Parish, Consolidated Waterworks District No. 1** - Not exceeding \$11,100,000 Water Revenue Refunding Bonds, not exceeding 4.5%, mature no later than November 1, 2023, refunding **(1)** Water Revenue Bonds, Series 2003A, and **(2)** Water Revenue Refunding Bonds, Series 2009.
20. **L12-204 - Terrebonne Parish, Consolidated Waterworks District No. 1** - Not exceeding \$17,300,000 Water Revenue Bonds, in one or more series, not exceeding 6%, not exceeding 25 years, **(1)** acquiring and constructing extensions and improvements to the Water System, including all necessary land, equipment and furnishing, and all engineering, legal and other incidental costs and fees and **(2)** providing for a reserve.
21. **L12-210 - Terrebonne Parish, Consolidated Waterworks District No. 1** - Not exceeding \$4,200,000 Water Revenue Bonds (DHH), not exceeding 4%, not exceeding 22 years, constructing and acquiring improvements and extensions to the Water System, including all necessary land, equipment and furnishings, and all engineering, legal and other incidental costs and fees.
22. **L11-135A - Vermilion Parish, Southeast Waterworks District No. 2** - **(1)** Not exceeding \$1,637,000 Water Revenue Bonds, Series 2013, not exceeding 3.375%, not exceeding 40 years, acquiring and constructing improvements and extensions to the waterworks system, including appurtenant equipment, accessories and properties; **(2)** Not exceeding \$1,637,000 Bond Anticipation Notes, not exceeding 1.428%, not exceeding 14 months, interim financing.

24. **S12-014 - Board of Supervisors of Louisiana State University and Agricultural and Mechanical College** - Not exceeding \$44,000,000, not exceeding 5%, not exceeding 30 years, (1) refunding certain maturities of Auxiliary Revenue Bonds, Series 2004(B) and (2) funding a deposit to a debt service reserve fund, if required.

25. **S12-004 - Louisiana Housing Finance Agency (Guste Homes Phase III Project)** - Not exceeding \$30,000,000 Multifamily Housing Revenue Bonds (Volume Cap), in one or more series, not exceeding 12%, not exceeding 40 years, (1) acquisition, construction and equipping of a 155 unit low-rise multifamily housing development located in New Orleans and (2) deposit into certain funds as may be required to secure and market the Bonds.
26. **S12-011 - Louisiana Real Estate Commission** - Not exceeding \$950,000 Indebtedness, not exceeding 4.85%, mature no later than 15 years, refinancing a loan from Omni Bank incurred for acquiring, constructing, furnishing and equipping an office building to serve as the Baton Rouge headquarters.
27. **S12-012 - Louisiana Offshore Terminal Authority (LOOP LLC Project)** - Not exceeding \$22,345,000 Revenue Refunding Bonds, Series 2012, fixed or variable not exceeding 10%, mature no later than October 1, 2020, refunding Deepwater Port Refunding Revenue Bonds, Series 2000.
