4. **L16-137 - St. Tammany Parish, Fire Protection District No. 2** - Not exceeding \$4,050,000 Limited Tax Certificates of Indebtedness, not exceeding 2.50%, mature no later than March 1, 2030; (1) approximately \$3,000,000 for acquiring, constructing and improving fire protection facilities and equipment and (2) approximately \$1,050,000 for refunding and extending Limited Tax Certificates, Series 2009.

14. **L16-144 - Natchitoches Parish, Waterworks District No. 2** - Not exceeding \$6,600,000 Refunding Bonds, Series 2016, not exceeding 5%, mature no later than November 1, 2046, refunding all or a portion of Water Revenue Bonds, Series 2004, 2008 & 2010 and Certificate of Indebtedness, Series 2012.
15. **L16-014 - Ouachita Parish, Town of Sterlington** - Not exceeding \$6,300,000 Water Treatment Utilities Revenue Bonds, in one or more series, not exceeding 5% fixed and/or 12% variable, not exceeding 35 years, (1) acquisition, construction, and installation of a water system with related infrastructure improvements, extensions, modifications, and additions to the sewer system and (2) funding a debt service reserve fund, if required.
