3. **L16-242 - Jefferson Parish Council, Sales Tax District** - 1% sales tax, 20 years, beginning December 2, 2022, (1) acquiring, constructing, replacing, improving, and maintaining sewerage, road and drainage projects; provided that the proceeds of the Tax collected within the presently constituted boundaries of each municipality within the District, except the Town of Jean Lafitte, be returned to said municipality to be used for any lawful purpose, with one-eighth of the Tax collected in the unincorporated area of the Parish to be given to the Jefferson Parish Sheriff for law enforcement, and with seven-eighths of the Tax collected in the unincorporated area of the Parish and all of the Tax collected within the Town of Jean Lafitte to be used by the District for the aforesaid purposes and (2) funding into bonds.
4. **L16-243 - Jefferson Parish Council** - 6.5 mills tax, 10 years, 2018-2027, acquiring, constructing, improving, maintaining and operating public library facilities and equipment.
